- **Inquiry into the "Status of Foreign Banks in Canada."** Recommendations focused on increasing the powers and status of the foreign banks in Canada.

Robin holds a B.A. (Hons) Business and Economics degree, as well as a Masters of Business Administration degree from the Schulich School of Business, York University, Toronto. He has also obtained the Partners, Directors and Officers, Branch Manager and Securities Advisor designations within the securities industry in Canada.
